The Charging Interface Initiative e.V. Work Packages

Representation of global positions cross industry

- Serve as local representative of the organization to members, prospective members, partners, prospective partners, and district representatives, and the general public.

- Follow up on requests and new contacts to make companies, EV stakeholders and relevant committees / working groups aware of the CharIN e.V.
- Build and maintain positive relationships with partners, industry organizations and members to execute on the mission of the organization and drive value to all parties involved.
- Identifying opportunities to build strategic partnerships with regional associations by signing an MoU.
- Optional: provide local address/phone number

Interaction with industry

- Membership acquisition.
- Provide guidance to new members.
- Follow up inquiries from current & potential members.
- Support our members in the region.

- Educate on CharIN activities & technical developments.

Communication of positions

- Communicate the requirements for electric charging based on ISO 15118 and the Combined Charging System defined in the CharIN Focus Groups and Task Forces to the relevant committees and working groups in Chile.
- Monitor activities and communicate developments and decisions for electric charging and adjacent fields to CharIN.

Presence / visibility at events

- Mapping of relevant events in Chile
- Represent CharIN at relevant meetings and conferences to intensify the dialogue with EV stakeholder.
- Speak on behalf of CharIN on conferences.
- Support the CharIN event team on organizing Festivals in the country.
